POSITION SUMMARY:

Works under the broad policy guidance and direction of the City Manager. Performs administrative and supervisory work necessary to plan, schedule and direct all activities of the Glenwood Springs Fire Department.

ESSENTIAL FUNCTIONS:

- 1. Directly and through subordinate supervisors, the Fire Chief is responsible for the overall evaluation of the Fire Department policies, standard operating procedures, implementation of comprehensive training program, evaluation of the Fire department personnel and the discipline of subordinate personnel.
- 2. Pursuant to State and Federal law, the Fire Chief functions as the City's designated emergency response authority for hazardous materials incidents within the City.
- **3.** The Fire Chief either directly or through subordinate personnel, coordinates with the City's Building Department for enforcement of the Uniform Fire Codes as adopted by the City.
- **4.** Responds as necessary to emergencies involving fire, medical and hazardous materials and when appropriate, assumes the role of Incident commander.
- 5. Interpersonal contact with the department's membership, the general public, business owners and staff and other members of the public may be necessary, maintaining professionalism as spelled out in the department's mission statement.
- **6.** Maintains effective working relationships with the Rural Fire Protection District, the City, the County, area fire districts, applicable State and Federal agencies, the general public, hospital personnel, service groups, educational groups, business owners and staff and other members of the public.
- 7. Upholds department mission statement: Provides Service through Dedication, Professionalism, and Excellence.

OTHER DUTIES: The job description is not designed to cover or contain a comprehensive listing of activities, duties or responsibilities that are required of the employee for this job. Duties, responsibilities and activities may change at any time with or without notice.

CORE COMPETENCIES:

- Learn, observe and follow safe firefighting and work practices. Specifically:

 - o Operation use and maintenance of pump engines, fire apparatus and other fire equipment.
 - o Master of principles of emergency medical service provision, basic or advanced life support.

- o Methods and techniques of handling hazardous materials.
- o Pertinent Federal, State and local laws, codes and regulations.
- o Geography and street layout of the City and district.
- o Methods and techniques of public relations and instruction related to fire suppression and prevention.
- Deal effectively with upset or emotional persons or patients.
- Think and act quickly and calmly in emergency situations.
- As assigned, drive fire apparatus or ambulance safely in varying traffic and weather conditions.
- Respond to requests and inquiries from the general public.
- Prepare a variety of technical and operational reports.
- Communicate clearly and concisely, both orally and in writing.
- Establish and maintain effective working relationships with those contacted in the course of work.
